### COURSE DESCRIPTION:

On both days, individual interval start course following the specific given order of control points.

### EVENT CENTRE:

Event centre: Čachnov – scout base camp, [see map](#)

### DISTANCES:

Event centre – Car parking: 0 m

Event centre – Accommodation: 0 m

Event centre – Start: will be specified before race (Bulletin 3)(less than 5km)

Event centre – Finish: will be specified before race (Bulletin 3)(less than 1km)

### START 00:

- Saturday: **12:00**, interval start
- Sunday: **10:00**, interval start

### TERRAIN:

Undulating slopes in the altitude of 600 – 783 metres with a dense network of roads of varying levels of difficulty.

### MAPS:

ISMTBOM 2010, scale for **long 1:15 000**, **middle 1:10 000**, equidistance 5m, Update 8/2020.

## PUNCHING SYSTEM:

Electronic SportIdent. System set to mode of distant punching **AIR+** (punching distance 150 – 200cm). Only SIAC punching will be possible, the posts boxes have no mechanic punching slot. Renting of SIAC will be possible for a fee. A refundable deposit for nonregistered competitors (2000CZK per item) might be charged.

## CLASSES:

- W11, W14, W17, W20, W21E, W21A, W21B, W40, W50, W60
- M11, M14, M17, M20, M21E, M21A, M21B, M21C, M40A, M40B, M50, M60
- MW10, OPEN

The rules of participation, estimated winner times and track distances are in accordance with the MTBO Implementing Instruction applicable for the year 2020.

## MW10

On both competition days there will be MW10 track. The exact shape of the track for this category will be specified in Event instructions (Bulletin 3). Most probably it is going to be a simple, funny track with ribbons that can be completed by bike or on foot. Parents shadowing is allowed in this category. However, if the shadower is a competitor, must have completed their race first.

## Category OPEN (incomers, without license):

To start in the category OPEN no registration license is required. You can sign up for the race either by the registration system ORIS (see Registration) or via link Jednorázová přihláška (ONE OFF REGISTRATION)

The registration fee for competitors for OPEN category in regular time via ORIS system is reduced to 100 CZK/ race. In the case of late registration or on the spot registration, the fee is 200 CZK/ race.

#### **KINDERGARTEN:**

Supervised childcare is provided free of charge during the races.

#### **PROTESTS AND COMPLAINTS:**

In writing to the main referee, together with a deposit of 400, - CZK.

#### **RULES:**

The races are run in accordance with the MTBO Rules, Competitions guidelines and CSOS Implementation Instructions for 2020.

#### **EMBARGOED AREAS:**

From the date of this bulletin, entry restrictions to the race zone are applicable in accordance with the provisions of section 11 (3) of the applicable MTBO Rules. The race site is situated between the villages Čachnov, Svratouch, Svratka, Křížánky, České Milovy, Pustá Rybná, Borová, Pustá Kamenice. See [embargoed areas map](#).

#### **NOTICE:**

There is a strict prohibition of free-ride cycling. Failure to comply will be a reason for disqualification. More detailed information will be specified in the Event instructions BULLETIN 2.

Equipment check will be performed at start for M/W11, M/W 14, M/W 17 classes only. **You will not be admitted to the race without wearing a helmet.** The bikes of all competitors must have the tires with minimal width of 1.5".

#### **GDPR**

Event registration for the Races is considered as a personal consent to publication of personal data within the given format of ČSOS, that is: Registration, Starting list a Results on the Event webpages, online information system ORIS and the Event information sheets for the Competitors on sight. During the Event there might be documentary photos taken in order to inform the public about the Races, or to document the billing of subsidies and so on according Section 89 Act No 89/2012 Civil Code of Czech Republic. Furthermore there might be personal photo taken for private use of competitors, sport club presentation for example from the Finish zone, Winner Ceremony and similar. If you do not consent to be photographed, please explicitly notify the photographer.

#### **SPECIAL RULES**

Due to ongoing COVID situation, the Event Organizer reserves the right to undertake some non-standard special organisational measures according the actual situation and the mandatory regulations, e.g. adjusting start intervals, splitting in to starting groups to meet the limits of the total permitted number of persons, organizing of Start and Finish zone, limiting mass activities or taking sanitary measures, etc. Further clarification of this point will be published in an extra supplement to the Event Bulletins.
